12.01.01 To approve and authorize County Judge to sign Interlocal Agreement and Lease Agreement (Exhibit A to Interlocal Agreement) between Wichita County and Vernon College for the Detention Center Annex (commonly known as the "Sprague Unit") for period of January 1, 2012 and ending on December 31, 2017. 12.01.02 To file the Criminal District Attorney's 2012 Anticipated Budget for CDA Forfeiture Special Fund and DED Forfeiture Fund and Fund 244 – Hot Check Fund. A copy of each budget is attached hereto as Exhibit "B".
