Motion made by Commissioner Presson and seconded by Commissioner Mahler to approve and authorize the following consent agenda items, 12.04.250 through 12.04.256:

12.04.261 Motion made by Commissioner Norriss and seconded by Commissioner Presson to approve and file plat of lots 1-15 Antelope Creek Subdivision Section One out of the R.J. Scott Survey A-256 and the McKinny and Williams Survey A-238.

12.04.262 Motion made by Commissioner Norriss and seconded by Commissioner Presson to approve quote from B & H for three (3) Fujitsu fi-6130z ADF Color Scanners for the CMO offices in the amount of \$859.99 each, for a total amount of \$2,579.97, with free shipping. To be paid by transfer from the JP Technology Fund to the appropriate line as determined by the County Auditor.

12.04.263 Motion made by Commissioner Presson and seconded by Commissioner Mahler to approve up to \$18,000 for temporary handicap ramp for front entrance during construction to be paid from Permanent Improvement Fund.
