Motion made by Commissioner Presson and seconded by Commissioner Mahler to approve and authorize the following consent agenda items, 12.05.315 through 12.05.321:

12.05.315 To approve and ratify the minutes for May 14, 2012 regular session.

12.05.316 To reappoint Mrs. Joella Sue Nunn as the county appointee to Place 7 on the Helen Farabee Regional MHMR Centers Board of Trustees for a two-year term effective September 1, 2012 through August 31, 2014.

12.05.317 To file Edoctec invoice no. 13695 in the amount of \$3,175.00 with County Auditor for payment processing to be paid from 238.238.4670.
