Motion made by Commissioner Presson and seconded by Commissioner Mahler to approve and authorize the following consent agenda items, 12.07.395 through 12.07.398:

12.07.395 To approve and ratify the minutes for June 25, 2012 special session.

12.07.396 To approve the purchase of postage in the amount of \$7,000.00 for the Courthouse postage machine and \$5,000.00 for the Annex postage machine.

12.07.397 To accept proposal from Corlett, Probst & Boyd, P.L.L.C. for professional services to review and revise County subdivision regulations at a cost not to exceed \$2,500.00, with payment from Joint Road and Bridge Fund by transfer to proper budget line.

12.07.398 To approve the following for all elections held in 2012 unless specifically stated:
