Motion made by Commissioner Gonzalez and seconded by Commissioner Norriss to set the maintenance and operation (M&O) rate at the proposed rate of \$0.513590.

"I move that the property tax rate for Wichita County be set at the calculated effective tax rate of \$0.513590."

THIS BUDGET WILL RAISE LESS REVENUE FROM PROPERTY TAXES THAN LAST YEAR'S BUDGET BY AN AMOUNT OF \$-122,733.00, WHICH IS A 0.37 PERCENT DECREASE FROM LAST YEAR'S BUDGET. THE PROPERTY TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR IS \$196,013.00
