13.08.500 Motion made by Commissioner Mahler and seconded by Commissioner Presson to take proposals submitted for the Jail Door/Intercom Control Panel from Metroplex Control Systems, and Sydaptic, Inc. under advisement and bring them back at a later date.

Motion made by Commissioner Presson and seconded by Commissioner Mahler to approve the purchase of a Dell Mobile Precision M4700 for Sheriff's Office Training Officer for an amount no to exceed \$2,445.46 to be paid by transfer from 100.412.3153, Office Equipment, over \$500, less than \$5,000, to line item determined by County Auditor.

Motion carried unanimously.

Motion made by Commissioner Norriss and seconded by Commissioner Gonzalez to approve the purchase of parts from Bass Computers for an IT built computer for the Tax Office for an amount not to exceed \$950.00 to be paid by transfer from 100.412.3153, Office Equipment, over \$500, less than \$5,000, to line item determined by County Auditor.

Motion made by Commissioner Mahler and seconded by Commissioner Gonzalez to adopt the County Clerk's increased records archive fee, from \$5 to \$10, for preservation and restoration of public documents and records pursuant to HB 1513 passed during the 83rd Legislative Session, Local Government Code §118.011(f).

Motion carried unanimously.

- 2. Briefing and discussion with Wichita County District Attorney's Office regarding settlement of accident claim with Sieglinde Perdue involving Constable Brewer. This meeting was closed pursuant to Section 551.071 of the Texas Government Code (consultation with attorney).
