Motion made by Commissioner Presson and seconded by Commissioner Norriss to approve and authorize the following consent agenda items 13.09.539 through 13.09.546, with changes to Item #2:

- 13.09.539 To approve and ratify the minutes for September 9, 2013 regular session.
- 13.09.540 To file City of Wichita Falls invoice no. 0005 in the amount of \$413.54 with the County Auditor for payment processing for fuel for trucks used during the Walker Road Fire on August 29, 2013 to be paid from 100.409.4902, General Fund Contingency, to line(s) as assigned by County Auditor. The fuel billed in this invoice was for the Wichita County Sheriff's Office, Burk VFD, Burk VFD Brush #3, Friburg Cooper VFD, Wichita West Fire Department, Iowa Park #10, and the American Red Cross. Because the area burned (150 acres) was unincorporated land, the County provides the fire services necessary to contain and put out the fire in the interest of public safety.

Motion made by Commissioner Norriss and seconded by Commissioner Presson to approve the purchase of parts from Bass Computers for one (1) IT built computer for Records Management, at a total cost not to exceed \$1,090.00, to be paid by transfer from 100.412.3152, Office Equipment, to appropriate line as determined by County Auditor.

Motion made by Commissioner Presson and seconded by Commissioner Norriss to approve the hiring of one (1) full-time Deputy Delinquent Tax Collector (100.499.11) in the Tax Assessor/Collector's Office and to approve an exception to the County's posting procedures and allow the Tax Assessor/Collector to select and hire the Deputy Delinquent Tax Collector without posting the position, at Grade 13, Step G-I, depending upon the qualifications of the final candidate, and to allow the candidate to be hired as soon as possible following the successful completion of all pre-employment testing.

Motion carried unanimously.

13.09.550 Motion made by Commissioner Presson and seconded by Commissioner Gonzalez to approve quote from Tex-Oma Builders Supply Co. to perform necessary repairs to bring the Scott Street entrance of the Annex Building up to fire code compliance, for a total cost of \$1,270.00, plus shipping costs for material, if any, to be paid from Permanent Improvement Fund.

13.09.551 Motion made by Commissioner Presson and seconded by Commissioner Norriss to approve quote from E.V. Electric & Security, Inc. to install automatic door openers for the outside Courthouse entrance doors, for a total cost not to exceed \$5,752.98, including all material, installation, and labor, to be paid from Permanent Improvement Fund.
