Motion made by Commissioner Presson and seconded by Commissioner Mahler to approve and authorize the following consent agenda items 14.05.233 through 14.05.237, with the removal of item #6:

14.05.233 To approve and ratify the minutes for May 12, 2014 regular session.

14.05.234 To authorize County Judge to sign credit application for Yellowhouse Machinery Company. A copy of the application is attached hereto as Exhibit "A".
