Motion made by Commissioner Presson and seconded by Commissioner Gonzalez to approve and authorize the following consent agenda items 14.07.332 through 14.07.340:

14.07.332 To approve and ratify the minutes for July 14, 2014 regular session and July 15, 2014 budget work session.

14.07.333 To file Work Order MS-2014-979 in the amount of \$2,500.81 on City of Wichita Falls invoice 07-14SD for repair of Sheriff Office Dodge Charger transmission as part of invoiced amount of \$25,147.56 with the County Auditor for payment processing with payment from 100.560.4456, Repair & Maintenance, Vehicles by transfer to appropriate budget line, if necessary.

14.07.334 To notify Texas Department of Motor Vehicles that Wichita County selects Option A to retain the \$10 optional R & B fee for 2015. A copy of the notification is attached hereto as Exhibit "A".
