Motion made by Commissioner Presson and seconded by Commissioner Mahler to approve and authorize the following consent agenda items 14.11.560 through 14.11.573, with a modification to Item #13:

- 14.11.560 To approve and ratify the minutes for November 10, 2014 regular session.
- 14.11.561 To adopt proclamation Celebrating Thirty Years of "Weather with Skip McBride".
- 14.11.562 To file the Texas A & M AgriLife Extension Agents' Monthly Reports for October, 2014.
- 14.11.563 To file Cullar Auto & Truck invoice #0018109 in the amount of \$9,141.26 with the County Auditor for payment processing for repair of Precinct #1 Ford F550 truck with payment from 221.210.4456, Repair & Maintenance, Vehicles, by transfer from other Department 221 operating and supply lines to make up shortage.
- 14.11.564 To file certificates of participation for six (6) hours of educational training during the District 3 County Judges and Commissioners Conference, November 6, 2014, for Commissioners Gonzalez, Norriss, Mahler, and Presson.

14.11.571 To approve the transfer of funds, as necessary, (estimated to be less than \$50,000) from 491 Voter Registration and 492 Primary Elections to fund the projected deficit in Department 490 Elections, to the appropriate lines as determined by the County Auditor, to cover the costs of the November election and other expenses through the end of the year.

General Fund Contingencies will be reimbursed in 2015 with incoming receipts.

14.11.573 To file Lance Spruiell Business Forms invoice #141017-086 in the amount of \$3,410.00 with the County Auditor for payment processing for Court Docket Folders for the District Clerk's Office to be paid from 100.430.3306, Books and Binders.

14.11.574 Motion made by Commissioner Norriss and seconded by Commissioner Gonzalez to approve the emergency and regular bills for payment.

14.11.575 Motion made by Commissioner Mahler and seconded by Commissioner Norriss to accept the results of the canvassing of the November 4, 2014 General Election. A copy of the report is on file in the County Clerk's Office.
