Motion made by Commissioner Presson and seconded by Commissioner Mahler to approve and authorize the following consent agenda items 14.12.657 through 14.12.660 with correction to item #2 and the removal of #5:

14.12.657 To approve and ratify the minutes for December 22, 2014 special session.

14.12.658 To file Browse Shop invoice #207659 in the amount of \$381.00 and invoice #207660 in the amount of \$2,794.00 for payment processing with the County Auditor for boots for the WCSO Honor Guard to be paid by transfer from the appropriate line as determined by the Auditor and reimbursed by the 2014 Edward Byrne Memorial Justice Assistance Grant (JAG) Program.

14.12.659 To transfer \$1,000.00 to cover the county match for the CETRZ administration fee from the Road & Bridge Joint Fund's Capital Expense Budget line, 225.250.5501 to CETRZ Fund, 712.900.2250.

The temporary clerk will continue as an employee of the temporary staffing company during this work assignment and will have no Wichita County benefits.

Menasco Roofing Co. estimate #395 of December 11, 2014 and Change Order for project, if needed. A copy of the estimate is attached hereto as Exhibit "A".
