Motion made by Commissioner Mahler and seconded by Commissioner Watts to approve and authorize the following consent agenda items 15.01.38 through 15.01.48:

15.01.38 To approve and ratify the minutes for January 12, 2015 regular session.

15.01.39 To file U & D Enterprises, Inc. invoice #12217 in the amount of \$2,076.97 with the County Auditor for payment processing for road signs and fasteners for Precinct 4 with payment from 2015 budget line 224.240.3308, Signs.

15.01.40 To file Wichita Falls Freightliner invoice #SS750050246:01 in the amount of \$1,360.72 and invoice #SS750050346:01 in the amount of \$744.93, for a total of \$2,105.65, for service and repair of Precinct 2 Freightliner M2 truck tractor with payment from 2104 budget line 222.220.4456, Repair & Maintenance, Vehicles, by transfer from other budget lines as necessary.

15.01.51 Motion made by Commissioner Gonzalez and seconded by Commissioner Mahler to authorize Court Administrator to hire an Indigent Defense Coordinator and to approve candidate to be paid at Step/Grade 15 A-C with a possibility of advancing to Grade D which is budgeted, with County Judge's approval, and to approve up to a three (3) week overlap in that position to allow for training.

15.01.52 Motion made by Commissioner Mahler and seconded by Commissioner Watts to award bid for Wichita County Courthouse County Clerk Office Renovation to Falls Construction Co., Inc. as apparent low bidder at \$326,428.00 to be paid from Permanent Improvement Fund and authorize County Judge to sign contract documents and notice to proceed. A copy of the documentation is attached hereto as Exhibit "B".
