Motion made by Commissioner Mahler and seconded by Commissioner Watts to approve and authorize the following consent agenda items 15.03.150 through 15.03.154:

15.03.150      To approve and ratify the minutes for March 9, 2015 regular session.

15.03.151      To ratify County Judge's signature on Scope of Work Review and Approval Form from Justice Solutions / Correct Care Solutions. A copy of the agreement is attached hereto as Exhibit "A".

15.03.152      To approve additional vehicle, 2014 Dodge Charger be added to the District Attorney's fleet inventory.
