Motion made by Commissioner Gonzalez and seconded by Commissioner Harvey to approve the increase in salary for Mitizi Brotherton to \$50,762.74 effective October 1, 2015 to June 30, 2016 with an increase to \$52,793.27 effective July 1, 2016\*, and to approve an increase in salary for Anayel Aviles to \$41,573.00 effective October 1, 2015 to June 30, 2016 with an increase to \$43,785.64 effective July 1, 2016\*. Position 03 will be renamed Indigent Defense Coordinator with a salary of \$32,184.55 effective October 1, 2015 to June 30, 2016, with an increase to \$33,471.93 effective July 1, 2016\* and position 04 will be Deputy Court Administrator I with a salary of \$30,946.68 with an increase to \$32,184.55 effective July 1, 2016\*. \*Salary increases are conditional upon meeting departmental requirements of developing job descriptions, filling positions 03 and 04, and developing Standard Operating Procedures for the Court Administrators Office to meet the needs of the five courts served.
